



VIOLENT DEATH IN NORTH CAROLINA: CONGRESSIONAL DISTRICT 13, 2023

• An estimated 799,277 North Carolina residents reside in Congressional District 13.

- In 2023, there were 143 violent deaths from injuries sustained by individuals living in Congressional District 13.
- The majority of decedents were residents of Johnston (21%), Harnett (18.9%), and Franklin (13.3%) counties.








• There were 93 suicides (65.0%), 39 homicides (27.3%), two unintentional firearm deaths (1.4%), three deaths from legal intervention (2.1%) and six deaths of undetermined intent (4.2%).

- Firearms were involved in 53.8% of suicides and 76.9% of homicides.
- Among homicides caused by firearms, 73.3% were caused by handguns, 0% by shotguns, and 13.3% by rifles.
- Among suicides caused by firearms, 74% were caused by handguns, 18% by shotguns, and 6% by rifles.
- The second leading method of death for suicide was hanging, strangulation, or suffocation (22.6%).

Firearms were involved in 60.6% of all homicide and suicide deaths Method of Death: Congressional District 13, NC*



The North Carolina Violent Death Reporting System (NC-VDRS) is a CDC-funded statewide surveillance system that collects detailed information on violent deaths that occur in North Carolina, including homicide, suicide, unintentional firearm deaths, legal intervention and deaths of undetermined intent. NC-VDRS triangulates information from death certificates, medical examiner reports, and law enforcement reports to understand and aid in the prevention of violent deaths. Data reported in this document are based on residential address of the victim and, instead of a rate, the ratio is reported. This document summarizes fatal injuries from violence that occurred in Congressional District 13 for the year 2023. Since not all deaths resulting from violence are able to be geocoded, the violent death numbers represented in this fact sheet may be slightly underestimated.

Manner of Death by Age Group: Congressional District 13, NC*




^{*}Age group percents are taken of total homicide, total suicide and total overall violent deaths

- Suicides and homicides displayed different age patterns.
- Percentage of total homicides peaked among those 35-44 with 25.6% of total homicides, where percent of total suicides peaked among those 45-54 with 22.6% of total suicides.
- Percentage of overall violent deaths peaked among those 45-54 at 19.6% of total violent deaths.

- The majority of suicide and homicide victims were male. There were 71 male suicide victims and 32 male homicide victims, which accounted for 76.3% and 82.1% of victims, respectively.
- There were 22 female suicide victims and 7 female homicide victims, which accounted for 23.7% and 17.9% of victims, respectively.


Males consistently have higher proportions of violent deaths than females

Manner of Death by Race: Congressional District 13, NC*



- Patterns of suicide and homicide differed by race. 78.5% of suicide victims were Non-Hispanic (NH) White while only 10.8% were NH Black.
- In contrast, 51.3% of homicide victims were NH Black, and 35.9% were NH White.
- Overall, there were 12 (8.4%) Hispanic, 95 (66.4%) NH White, 32 (22.4%) NH Black, 0 (0.0%) NH American Indian, and 1 (0.7%) NH Asian victims.
