

VIOLENT DEATH IN NORTH CAROLINA: CUMBERLAND COUNTY INCIDENTS, 2014-2023

The North Carolina Violent Death Reporting System (NC-VDRS) is a CDC-funded statewide surveillance system that collects detailed information on violent deaths that occur in North Carolina, including: homicide, suicide, unintentional firearm deaths, legal intervention, and deaths of undetermined intent. NC-VDRS uses information from death certificates, medical examiner reports, and law enforcement reports to understand and aid in the prevention of violent deaths. Data reported in this document are based on the county where the death occurred rather than county of residence. ¹The occurrent ratio is used instead of the rate. This statistic is derived from the total number of violent deaths resulting from injuries in a specified geographic region divided by the number of residents in the region.


Manner of Death: Cumberland County, NC: NC-VDRS, 2014-2023*




- For the years 2014-2023, there were 1055 violent deaths from injuries sustained in Cumberland County. Of these 1055 deaths, 1022 were NC residents (96.9%) and 943 were Cumberland County residents (89.4%).
- There were 546 suicides (51.8%), 457 homicides (43.3%), 12 unintentional firearm deaths (1.1%), 17 deaths from legal intervention (1.6%), and 23 deaths of undetermined intent (2.2%).

- In Cumberland County, the suicide ratio was 3.3 times higher in males than females, and the homicide ratio was 4.0 times higher in males than in females.

*Rate per 100,000 based on the county of injury occurrence. Chart excludes eight deaths of unknown or other race/ethnicity.


- The suicide rate was highest among non-Hispanic (NH) American Indian victims (30.9) suicides per 100,000 population) followed by NH White victims (27.4 per 100,000).
- In contrast, the homicide rate was highest among NH Black victims (26.0 per 100,000 population) followed by NH American Indian victims (24.6 per 100,000).

- Suicides and homicides displayed dissimilar age patterns. Homicide rates peaked among those aged 25-34 with 25.0 homicides per 100,000, while suicide rates peaked among those aged 85 and older with 29.6 suicides per 100,000.
- Over three quarters of homicides (81.6%) and more than half of suicides (61.4%) involved firearms.
- Suspicion of intoxication was reported in 11.6% of homicides and 19.8% of suicides.
- For homicide incidents where one or more suspects were identified, the relationship of the victim to the suspect was known (current or former spouse/boyfriend/girlfriend, family, friend or acquaintance) more frequently for female (71.7%) than for male (44.1%) victims.

- Sixty-nine percent (68.9%) of female and 43.8% of male suicide victims were characterized as having a current mental health problem.
- Females (29.4%) were more likely to have attempted suicide in the past as compared to males (12.5%).

^{*}Based on the county of injury occurrence, 93.9% of cases had circumstance information. One female and 27 males were missing circumstance information.

- Arguments or conflicts were more likely to be a contributing factor for male homicides (42.9%) than for female homicides (40.7%).
- Twenty-two percent (22.0%) of female homicides and 35.5% of male homicides were precipitated by another crime such as robbery, burglary, or drug trafficking.
- Intimate partner violence was a contributing factor in 46.2% of female homicides, but only 11.2% of male homicides.
