### **Disaster Impact Report Portal**


- Method for regulated child care programs to report impacts of declared disasters to DCDEE
- Information access point for DCDEE to make funding determinations (if or when funding comes available)
- Method to distribute funds to regulated child care programs in response to disasters (once funding has been received and funding determinations have been made)
- Data and evidence availability to state and federal government officials of the need for assistance or the need of a policy to address an issue



### \$27 Million Preschool Development B-5 Grant (PDG)

- North Carolina is one of 11 states awarded a PDG Renewal Grant.
- Key Personnel
  - Nicole Boone PDG B-5 Project Team Lead
  - Katherine Falen
     – PDG Grants Manager
- \$9 million per year for three years: September 30, 2024, through September 29, 2027
- Builds on state's past success
- Supports implementation of the revised Quality Rating and Improvement System





# **Legislative Updates (cont.)**

- New Legislature convened January 8, 2025 for "Long" Session
- DHHS/DCDEE Legislative Priorities include, but not limited to:
  - Alternative Market Rate Study Rates
  - Stabilization Grants
  - Certified Developmental Day Centers
  - QRIS Implementation
  - Disaster Recovery





# **Child Care Rule Updates**

- Amended 10A NCAC 09 .0713 Staff/Child Ratios for Centers Training module available in Moodle
  - Effective November 1, 2024
  - aligns ratios and capacity for centers located in a residence with nonresidential child care centers for children ages 3 years and older
  - o staff/child ratios for centers located in a residence are increased from 1/12 to 1/15 for children ages three and older
  - o change applies only to centers located in a residence with a licensed capacity of 13 to 15 children
- Quality Rating Improvement System (QRIS) Modernization Rules
  - In March the Child Care Commission held a public hearing for proposed the QRIS modernization rules followed by a special closed session meeting to discuss all public comment
  - Voted to adopt rules on April 22




# **Child Care Rule Updates (cont.)**

#### Periodic Review of Rules

- NC Administrative Procedures Act requires review of all existing rules in the NC Administrative Code every 10 years
- Multi-step process beginning with the Child Care Commission making initial determination recommendations of "necessary" or "unnecessary" for each rule
- Initial Determinations Report approved by Child Care Commission in September 2024 is posted for Public Comment (will be extended due to Helene impacts)
- Child Care Commission reviewed and responded to public comments and submitted a report,
   comments, and rule classifications to the Rules Review Commission
- Following Rules Review Commission and Administrative Procedure Oversight Committee review and approval of Final Determinations Report, a readoption schedule for all rules determined necessary will be established
- A public comment period and public hearing will be held for all readopted rules and rules may be amended during the readoption process

### What is proposed to change?

- Shifting to a Star Level System, instead of a points-based system
- Addition of two licensure pathways to earn a 2-5 Star Rated License
- Use of ERS-3 and SACERS-U for program assessment, instead of ERS-R
- Addition of Family & Community Engagement Standards
- Addition of Continuous Quality Improvement Standards
- Choices in education standards to include the CDA, early childhood education certificates, work experience, training and competency evaluations
- Coaching/mentoring opportunities
- Acknowledgment of quality initiatives, in addition to QRIS standards




