Q. For school communities (both students/staff) - would you recommend proactively advising families now to check their immunization status and make sure they are up-to-date? Students' vaccine status is tracked, but staff in public schools are not required to submit vaccine status. (Lisa Pursell-Morris)
A. Absolutely!

Q. The meeting re measles you mentioned earlier....is that just for HD staff?

**Q.** Are there any shortages anticipated of MMR vaccine? Should we titer first before vaccine for folks born after 1957 who are uncertain about immunity and vaccine history?

**A.** There is no known shortage of MMR so it is up to the patient preferences on whether to get titers first (which can be costly) or to just go ahead and immunize if eligible.

**Q.** Can you discuss updates coming to NCIR

**A.** We have secured a vendor for a new NCIR which is still planned to launch in 2025. More information for providers should be coming shortly. **Q.** For individuals with unknown measles immunity, it is recommended to draw titers, rather than give a booster, to preserve quantities of MMR for those who truly need it?

**A.** There is no known shortage of MMR so it is up to the patient preferences on whether to get titers first (which can be costly) or to just go ahead and immunize if eligible.

**Q.** I would love more info regarding being prepared for possible measles cases in the school setting. **A.** A webinar for school nurses is being planned.

**Q.** What if an individual had just one measles and Rubella vaccine approx 1970. Do we give MMR? and if so one or two doses?

**A.** If they have only had one dose of measles vaccine they would need a 2nd MMR to complete the 2 dose series. For protection for mumps they would need a 2nd MMR, call 919-707-5575 if you need more info.
