Minutes Well Contractors Certification Commission Meeting

I. Preliminary Matters

- (1) Chairman Todd Muench called the meeting to order and requested cellular telephones be silenced.
- (2) Chairman Muench then read the NC State Government Ethics Act which mandates that the Chairman inquire as to whether any member knows of a conflict of interest or appearance of conflict with respect to matters before the Commission. The Chairman asked if any member knows of a conflict of interest or appearance of a conflict. No conflict of interest noted.
- (3) A roll call was taken to verify a quorum

- (4) The chairman also read a statement on the purpose of the Well Contractors Certification Commission: (Article 7A-Well Contractors Certification, G.S. 87-98.3). **Purpose:** It is the purpose of this Commission to protect the public health and safety by ensuring the integrity and competence of well contractors, to protect and beneficially develop the groundwater resources of the State, to require the examination of well contractors and the certification of their competency to supervise or conduct well contractor activity, and to establish procedures for the examination and certification of well contractors.
- (5) Notation of Any Revisions or Additions to the Agenda

A closed session to discuss staff was added to the agenda.

Commissioner Julian made a motion to enter into closed session. Commissioner Leggett seconded the motion. A roll call vote was taken and the motion passed unanimously. The meeting went into closed session at 10:14 AM.

Commissioner Deal made a motion to exit closed session. Commissioner Young seconded the motion. A roll call vote was taken and the motion passed unanimously. The meeting went into open session at 10:28 AM.

The Commission reviewed the August 9, 2022 meeting minutes. Commissioner Deal made a motion to approve the August 9, 2022, minutes. Commissioner Leggett seconded the motion. A roll call vote was taken and the motion passed unanimously.

(3) Independence from State Government versus additional staff

After discussion, Commissioner Leggett made a motion to rescind the previous decision to separate from State government and keep the WCCC housed within NC DHHS. Commissioner Julian seconded the motion. A roll call vote was taken and the motion passed unanimously.

(4) Additional enforcement position

Commissioner Young made a motion to hire an additional environmental specialist for enforcement purposes (possibly stationed in the western side of the State). Commissioner Julian seconded the motion. A roll call vote was taken and the motion passed unanimously.

(5) Print 2C and other references

Commissioner Leggett made a motion to have Corrections Enterprises print 1,500 copies of the Subchapter 2C Well Construction Standards. The rule books are to be mailed to certified well contractors with their 2023-24 renewal cards. Commissioner Deal seconded the motion. A roll call vote was taken and the motion passed unanimously.
