

## NC OCME Toxicology

- We are the **only** postmortem tox laboratory in North Carolina.
- We do toxicology testing for all <u>100</u> counties
- In the last 10 years our workload has increased from less than 10,000 cases a year to over <u>15,000</u> cases in 2022
- We do this with a <u>limited staff of 22</u>
   people, ¼ temporary/grant positions

### How do young children gain access to cannabis?

- A child found and ate a cannabis **chocolate** bar in the glove compartment of the car.
- A family friend was visiting, hung his coat on the back of a kitchen chair and a toddler found a cannabis **sucker** in the jacket pocket and ate some of it.
- A babysitter found a container of **cookies** up in the cupboard and not knowing they contained cannabis, shared this snack with the child in her care.
- A young child began staggering, and the mother realized that the leftover cannabis **cupcake** from the plate on the kitchen counter was missing.

**FACT:** CBD and THC are both cannabinoids found in cannabis plants.



## CBD: What is it, What it is not

- Cannabidiol (CBD) and tetrahydrocannabinol (THC) are both naturally occurring compounds found in plants in the cannabis genus.
- **CBD is non-psychotropic** and therefore does not illicit a "high" whereas THC is psychotropic does illicit a "high".


## Hemp CBD vs. Cannabis CBD

- Public interest in and the availability of CBD have grown due to its *promising* health benefits.
- Scientific studies have not confirmed CBD's usefulness for all these conditions companies promise it will treat.
- Hemp is a specific variety of *C. sativa*.
  - In most cases, manufacturers use the leaves and flowers of the hemp plant to make CBD products.
- There are three standard varieties of cannabis plants: *C. indica, C. sativa,* and *C. ruderalis*. There is also a range of hybrid plants that are a mix of these three strains.
  - These cannabis plants contain much higher and varying levels of THC than hemp plants.

Hemp and cannabis contain different amounts of CBD and THC.



Cannabis contains more THC, and less CBD. Hemp contains more CBD and less THC.



### THC in Edibles vs. CBD in Edibles



- Not to be confused with marijuana/cannabis that is smoked, CBD oil is legal
- CBD has been known to relax the muscles, studied for anxiety, cognition, movement disorders, pain
- All CBD food supplements are <u>restricted for sale to those aged 18 years and above</u>

• THC gummies can contain more than 20% THC while <a href="CBD gummies legally must contain less than 0.3% THC">CBD gummies legally must contain less than 0.3% THC</a>



"There is a common theme of not knowing what THC gummies are or what the effects might be and confusing them with real candy. One parent mistakenly offered the gummy to their child thinking it was candy."

### .....however, products are confusing

- Full-spectrum products derived from cannabis use <u>all</u> of the cannabinoids, terpenes, and molecular compounds within the cannabis plant, <u>which includes THC</u>—sometimes in very small, almost trace amounts, but sometimes in significant doses.
- **Broad-spectrum CBD products** contain all of the cannabinoids of the cannabis or hemp plant they are sourced, but have had the THC removed.
- CBD isolate products consist of nothing except CBD. No other cannabinoids, no terpenes, no nothing but pure CBD. These too, are often made from industrial hemp, instead of actual cannabis.



**Sleep aid.** CBN has shown to have sedative properties that could relieve conditions like insomnia. However, more research is required.

Unlike CBD, which is entirely non-psychoactive, CBN in larger doses can produce mild psychoactive reactions.

### CBD to Delta-8 THC

- Delta-8 THC is an active ingredient (cannabinoid) of the cannabis plant. But most delta-8 products are man-made from converted CBD oil.
- The biggest risk of delta-8 THC is that it's not regulated, which means that safety, purity, and strength can't be guaranteed.
- Delta-8 THC products likely expose consumers to much <u>higher</u> levels of the substance than are naturally occurring in hemp cannabis raw extracts.

### **Delta-8-THC craze concerns chemists**

Unidentified by-products and lack of regulatory oversight spell trouble for cannabis products synthesized from CBD

Move over cannabidiol (CBD). The popularity of another cannabinoid,  $\Delta^8$ -tetrahydrocannabinol (delta-8-THC), is on the rise. Found in gummies, vape cartridges, tinctures, and other products, delta-8-THC is popping up in gas stations, convenience stores, tobacco shops, and cannabis dispensaries throughout the US and beyond—often with no age restrictions.

But with no regulatory oversight and limited laboratory testing, most products sold as delta-8-THC are not actually pure delta-8-THC. Such products typically contain a high percentage of delta-8-THC and small amounts of other cannabinoids, including delta-9-THC, and reaction by-products. Some of the cannabinoids are not naturally found in cannabis. In most cases, nothing is known about the health effects of these impurities.

## Delta-8 Debate: The 2018 Farm Bill gave rise to an unlikely intoxicant

- When Congress passed the Farm Bill, hemp cultivators and processors were sitting on loads of CBD oil that, until then, was hard to move in a marketplace limited by lack of federal clarity on CBD. The new regulations undammed that supply, with CBD distillate unleashed along with a new wave of entrepreneurs looking to enter the industry.
- CBD prices dropped from \$25,000 per kilogram to as little as \$500 after the Farm Bill's passage. Suddenly, converting CBD into delta-8 THC was economically feasible.
- One of the reasons this didn't happen earlier is because anytime you have to do a conversion, it's an
  added expense. When CBD prices went through the floor, this raw material became really cheap.
  Previously, the barrier to doing this had been cost. And now that cost barrier was gone.
- In its effort to legalize and regulate hemp-derived CBD, the **2018 Farm Bill** stated that any cannabinoid derived from hemp-defined as cannabis containing less than 0.3% delta-9 THC-was a legal product.



# Not your parents' pot: North Carolina legislators and law enforcement agencies attempt to get delta-8 THC out of the hands of children



Many manufacturers and distributors have been using loopholes to sell products that are far more potent than state and federal law intended.






### Is Delta 8 THC Legal in My State?



## A total of 24 states have either banned or "severely restricted" delta-8 products.

With the number of states outright banning delta-8 THC goods seemingly increasing as quickly as the number that have legalized marijuana, the national patchwork of legality for hemp goods has become something of an ironic mine field for entrepreneurs.

So far, a total of 24 states have either banned or "severely restricted" <u>delta-8 products</u>, according to a new report from CBD Oracle, with 17 state bans in place. Where delta-8 products are legal, however, has strikingly little overlap with <u>state-legal marijuana</u>.





## Children who have consumed cannabis edibles may:

### THC poisonings on the rise

The <u>American Association of Poison Control Centers</u> reports receiving 4,329 calls about poisonings for kids under 12 years involving cannabis edibles containing THC — a significant increase from 3,132 calls in 2020; 1,364 calls in 2019; and just 187 calls in 2016.

- Act lethargic
- Feel dizzy
- Have trouble walking or sitting up
- Have an accelerated heart rate
- Trouble breathing





#### Several NC teens hospitalized after ingesting THC gummies at their middle school

Several students at a North Carolina middle school were treated Friday at a local hospital after showing signs of being impaired.

Deputies said that during the resulting investigation, a package of THC gummies and a quantity of marijuana were seized.

Jyquante Spruill, 14, was one of the students affected. His family was alerted that he had passed out in gym class and that paramedics were on the way.

"Slurred speech, stumbling, falling asleep, you know in severe cases if you took a lot of them, they could be life-threatening things like respiratory depression, shallow breathing," Ledoux said. "It could also cause things like vomiting and things that are much more life-threatening than just a mild intoxication."

## THC Contributions

- Some deaths have been attributed to smoked cannabis.
  - •Thrombus formation and stroke has been associated with use of cannabis.
  - Acute use of cannabis should be considered as contributory to death in some cases.

## Police: Mother charged with neglect after 2-yearTraci L. Miller old overdoses on THC

- 2-year-old daughter was given "Apple Jackz," a sweetened, apple and cinnamon flavored cereal with 500mg of THC "per treat."
- In the care of her grandmother, the woman said she gave the child the cereal from a diaper bag and thought it was the breakfast cereal Apple Jacks.
- The child ate eight or 10 of the treats before the grandmother realized something was wrong. The woman said the toddler's eyes began to roll to the back of her head and she called her husband who came home and then called 911.

• The 2-year-old was admitted to the hospital and an EKG had to be performed on her every two hours, according to the probable cause.

Virginia mother charged with murder after 4-year-old son dies from eating THC gummies

- 4-year-old son died from eating THC gummies.
- Authorities said Clements failed to get her son help quickly enough after the boy ingested a "large amount" of the gummies.



- An autopsy found THC the ingredient in marijuana that gets people high was the cause of death.
- A doctor told detectives that the boy **could have been saved if he received medical attention sooner**, according to authorities.
- Mother claimed she called poison control after the boy ate half of a CBD gummy and that officials told her he would be fine, NBC Washington reported.
- But police say claims did not match evidence, where a detective reported finding an **empty THC gummy jar** in the house where he was found.

"I believe that delta-8 has a legitimate place in therapeutics and potentially adult use," Hudalla adds. "But I just don't see anybody doing it appropriately. It's all bathtub gin."

### Regardless of Opinions on Lethality, so many unknowns

How to keep marijuana edibles out of the hands of kids?

- Don't have them in the home
- Store them safely
- Use Edibles with Caution
- Avoid buying THC edibles that come in packages that look just like real candies
- Talk to family members, friends, caregivers

The body takes longer to process ingested THC than inhaled THC, Kraft said. Symptoms of marijuana poisoning, such as vomiting, slurred speech and breathing difficulties, may not appear until hours after the edible is consumed, Kraft said.

## Cannabis in the Kitchen: Not just brownies

- Home products will also cause confusion among children
- These infused weed foods will be even <u>less labeled than commercial products</u> unless efforts are made
- Any fat or an oil-based ingredient can be infused with cannabis.
  - Such fats include butter, ghee, lard, shortening and other vegetable or nut oils.

## NC OCME Toxicology: THC compounds

- Toxicology will need detailed notes from LE or ME regarding these products
- We do not routinely test for phytocannabinoids as they have not historically known to be lethal on its own, we are currently only funded for cause and manner of death determination
- We will consider adding it routinely if appropriately funded to do so
- Currently a send-out test to our secondary testing laboratory, which will be an additional fee to the state

## Vaping and schools

Products that look like pens or highlighters can easily be hidden by students in classrooms

Teachers may not recognize e-cigs, and smoke detectors won't catch the aerosol

- A 17-year-old boy from Baker City, Oregon suffered injuries to his teeth, hands and face when an e-cigarette exploded in his mouth.


### Nicotine Toxicity: History

- For centuries, gardeners have used home-made mixtures of tobacco and water as a **natural pesticide** to kill insect pests
- The smoking of pipes and cigars spread quickly throughout the 1600s.
- In 1828, Wilhelm Heinrich Posselt, a doctor, and Karl Ludwig Reinmann, a chemist, both from Germany, first isolated nicotine from the tobacco plant and <u>identified it as a poison</u>.
- The tobacco industry exploded in 1880 when a machine was first patented to mass-produce paper cigarettes.
- Nicotine is isolated from the tobacco plant Nicotiana tabacum and sustains tobacco addition





## Acute Forensic Consequences: Nicotine Toxicity



- Chewing or snorting tobacco products usually releases more nicotine into the body than smoking.
  - Low nicotine doses stimulate the neural/cardiovascular systems, awakening effect with increased heart rate and blood pressure
  - High doses suppress the vital systems
- Other early features of nicotine ingestion at mild to moderate toxic doses are a burning sensation in the mouth and throat, nausea, vomiting, abdominal pain, headache, confusion, dizziness, weakness, miosis, urination and defecation.
- Ingestion of higher doses leads to arrhythmias, bradycardia, convulsions, coma, respiratory failure, rapid progression to hypotension, and death
- A lethal dose of nicotine has been estimated to be as less as 40mg in adults and 1 mg/kg in children. **However, it is** recommended that children who have ingested 0.2 mg/kg or more of nicotine Be Seen by a professional
- In one case, the patient ingested 5 mL (50 mg) of liquid nicotine, which corresponded to a dose of 3 mg/kg higher than the lethal dose which directly caused cardiopulmonary arrest and hypoxic brain damage.

## Accidental ingestion of E-cigarette liquid nicotine in a 15-month-old child: an infant mortality case of nicotine intoxication

- At the time, no regulations regarding childproof bottling and packaging or warning signs on liquid nicotine products
- Parents of Child provided 5mL of liquid nicotine mistaking it for cold medicine (concentration: 10 mg/mL)
- When the emergency medical technicians arrived, she was found to have pulseless electrical activity. Spontaneous circulation was restored after approximately 40 minutes of CPR
- The cotinine level in her urine was 1,716 ng/mL
- Despite intensive supportive care, severe anoxic brain injury was found on computed tomography and the child ultimately died.
- This fatality highlights the need for public health efforts to minimize such accidents.



# Pediatric Exposure to E-Cigarettes, Nicotine, and Tobacco Products in the United States

- From January 2012 through April 2015, the National Poison Data System received 29,141 calls for nicotine and tobacco product exposures among children younger than 6 years, averaging 729 child exposures per month.
- Cigarettes accounted for 60.1% of exposures, followed by other tobacco products (16.4%) and e-cigarettes (14.2%). The monthly number of exposures associated with e-cigarettes increased by 1492.9% during the study period.
- Children <2 years old accounted for 44.1% of e-cigarette exposures, 91.6% of cigarette exposures, and 75.4% of other tobacco exposures.
- One death occurred in association with a nicotine liquid exposure.

#### Child-resistant packaging for liquid nicotine refills

As of 2016, the federal government requires liquid nicotine to be sold in childproof packaging.

- In 2014, an 18-month-old Montgomery County boy drank liquid nicotine
- first child in the country to die from accidentally swallowing the toxic ingredient in electronic cigarettes
- The house was in disarray because a family member was in the process of moving in.
- Not knowing that Eli was going to be at the house, a relative left an uncapped bottle containing a nicotine solution on a low table in the dining room.
- The parents had their backs turned, unaware of the open bottle, according to the summary.
- When they looked back, the toddler was holding the opaque brown bottle.
- According to the coroner's report, he died from nicotine ingestion, which caused cardiac arrhythmia.



## Outbreak of Lung Injury Associated with the Use of E-Cigarette, or Vaping, Products

- Sixty-eight deaths have been confirmed in <u>29 states and the District of Columbia</u> (as of February 18, 2020).
  - Some deaths in patients less than age of 18
  - E-cigarette or vaping product use-associated lung injury (EVALI)
    - Laboratory data show that <u>vitamin E acetate</u>, an additive in some THC-containing e-cigarette, or vaping, products, is strongly linked to the EVALI outbreak.

- Due to the large amount and the high nicotine concentration of EC liquid, the ingestion for suicide can lead to cardiac death.
- We had two patients, a 27-year-old male who ingested about 23 mg/kg of nicotine and a 17-year-old female who ingested about 30 mg/kg of nicotine.
- Both patients presented seizure-like movement and cardiac arrest. They had metabolic acidosis and transient cardiomyopathy.
- The latter patient was the first adolescent to date with an attempt of committing suicide by ingestion of EC liquid.
- They were ultimately discharged with a cerebral performance category of 2 and 4, respectively. Increasing EC use may produce more cases of medical problems or suicide by nicotine intoxication.






## NC OCME Toxicology: Vaping compounds

- Toxicology will need detailed notes from LE or ME regarding these devices
- Because of COVID increases without increases to our staff, we **no longer** routinely test for nicotine unless we are still seeking a cause of death. For pediatric cases we will often add an organic base screen to capture any toxic concentrations of nicotine
- We do **not** currently routinely test for synthetic cannabinoids unless we are still seeking a cause of death.
- We are not funded for routine surveillance and cannot screen every case for SynCanns
- We are monitoring to keep up with drug trends and if needed we can send to secondary testing laboratory or not profits that can re-analyze for us.

## **Toddler Deaths Resulting from Ingestion of Iron Supplements -- Los Angeles, 1992-1993**

- During June 1992-January 1993, five children aged 11-18 months in the Los Angeles area died after ingesting iron supplement tablets
- An 11-month-old girl died in December 1992. A 2-year-old sibling had fed the younger child 30-35 prenatal iron tablets.
- Acute onset of gastrointestinal symptoms (i.e., vomiting and diarrhea) that may progress to shock, coma, seizures, and death.
- Hepatic and renal failure and cardiovascular collapse
- Gastrointestinal obstruction and hepatic cirrhosis

Vital sign abnormalities from cyanide include tachypnea, Kussmaul's respiration, respiratory arrest and hypotension. Patients experience vomiting, diarrhea, abdominal pain, dyspnea, weakness, lightheadedness and cyanosis, which then can progress to coma, seizures, dysrhythmias and cardiovascular collapse.



### American Academy of Pediatrics, Hospital advice on Melatonin



- Neurohormone developed in pineal gland
  - Pineal gland develops completely postpartum
  - Newborn infants don't make endogenous melatonin (supplied through placenta and milk).
    - At peak circadian rhythm, <u>human breast milk will contain ~24 pg/mL</u>

## Melatonin and Unsafe sleeping Questions

- UNC Pediatric Sleep expert said: A melatonin supplement is not a sedative!
- Literature said: Melatonin's mechanism remains unknown.

- Does exogenous melatonin impact a baby's ability to correct sleeping position?
  - Is there an increased odds of suffocation from unsafe sleeping position?

"It's a prescription of desperation really; doctors don't know what to do about sleep and feel they have no alternatives,"
Stanley said. "That is terrible as it affects all body clocks and it will affect children's developmental clocks and we have no idea what that does."



### Melatonin (re)considerations from the literature

- In Europe, melatonin is a "neurohormone" and cannot be sold OTC
- Listed as "possibly safe" for children when taken by mouth for a **short period of time**,

but "should be reserved for children with a medical need."

- Considering extensive and yet not known effects on development, it should not be used by pregnant or breast-feeding women before further studies.
- Further studies are required to confirm that there are no late onset adverse reactions in adult life
  - "Should endocrine or other abnormalities appear in the future in children previously treated with melatonin, it will not be tenable to argue that we were surprised."





## NC OCME Toxicology: Melatonin

- Toxicology will need detailed notes from LE or ME regarding these products
- We do **not** routinely test for melatonin at exogenous concentrations unless requested because of scene evidence
- Cases of exogenous melatonin in pediatric cases will be missed unless we lower our limits of detection AND receive increased funding to help routinely test. Method development/validation work will require dedicated staff positions we do not have.
- Currently a send-out test to quantitate melatonin
