Re: Distribution of Specimen Collection Materials for Measles

On Wednesday, January 14, 2026, the North Carolina State Laboratory of Public Health (NCSLPH) began distributing new specimen collection materials for measles testing to all NC Local Health Departments (LHD). Collection supplies are intended to help prepare NC LHDs to submit specimens to NCSLPH during a potential measles event in their jurisdiction. These materials are also intended to replace any existing inventory of viral transport media that expires January 23, 2026.

Specimen collection materials will be delivered to LHD laboratories during business hours via the NC Department of Administration (DOA) Medical Courier. LHDs that do not use the NC DOA Medical Courier will receive supplies via UPS. Please contact NCSLPH Customer Service (919-733-3937) if materials are not received by close of business on January 20, 2026.

Each LHD will receive:

- 5 Ultrafine Puritan flock swabs for nasopharyngeal (NP) specimen collection (product #3317-U)
- 5 Tubes of Remel M4RT Viral Transport Media (product #R12700)

Those LHDs involved in the response to recent cases of measles in NC will receive additional collection supplies.

Provided materials may be stored at room temperature prior to specimen collection. Please dispose of expired supplies. **No expired swabs or viral transport media should be used for specimen collection.** Visit the [NCSLPH guidance document](#) for more information on measles specimen collection, storage, and transport.
