# Maternal Mortality in North Carolina 2018-2020

The North Carolina Maternal Mortality Review Committee (MMRC) was established by state law in 2015. The purpose of the MMRC is to review all maternal deaths of NC residents and develop actionable recommendations aimed at the prevention of future material deaths. This fact sheet highlights data for all pregnancy-related deaths that occurred from 2018 to 2020 in North Carolina.


## PRMR by Race/Ethnicity

- **57** pregnancy-related deaths per 100,000 live births among Non-Hispanic Black women
- **32** pregnancy-related deaths per 100.000 live births among non-Hispanic white women
- **25** pregnancy-related deaths per 100.000 live births among Hispanic women
- **46** pregnancy-related deaths per 100,000 live births among Non-Hispanic women of other races



Note: The number of pregnancy-related deaths for NH Asian/Pacific Islander, Multiracial and American Indian/Alaskan Native groups are too small to calculate reliable PRMRs)

#### **Leading Causes of Pregnancy-Related Deaths**



- Mental Health Conditions (including Overdose & Suicide) are the Leading Cause of Pregnancy-Related Death for:
  - Non-Hispanic White (29 deaths)
  - Hispanics (7 deaths)
  - Non-Hispanic Other Races\* (5 deaths)
- Cardiovascular Conditions (including Cardiomyopathy) are the Leading Cause of Pregnancy-Related Death for:
  - Non-Hispanic Blacks (12 deaths)

Note: The number of deaths for NH Asian/Pacific Islander, Multiracial & American Indian/Alaskan Native groups are too small to report (<5 deaths overall) the leading cause of death

- Overdose Prevention and Substance Use Disorders
- Management of Chronic Diseases in Pregnancy
- Management of Obstetric & Postpartum Emergencies

Definition: Pregnancy-related death: A death while pregnant or within one year of the end of pregnancy from a pregnancy complication, a chain of events initiated by pregnancy, or aggravation of an unrelated condition by the physiologic effects of pregnancy. (Q: "If she had not been pregnant, would she have died?")
